



TERMS AND CONDITIONS

OVERVIEW

This website is operated by The Caribbean Housewife. Throughout the site, the terms “we”, “us” and “our” refer to The Caribbean Housewife. The Caribbean Housewife offers this website, including all information, tools and services available from this site to you, the user, conditioned upon your acceptance of all terms, conditions, policies and notices stated here.

By visiting our site and/ or purchasing something from us, you engage in our “Service” and agree to be bound by the following terms and conditions (“Terms of Service”, “Terms”), including those additional terms and conditions and policies referenced herein. Duration And Delays

Your seat is booked for 2 hours starting from the time of the confirmed reservation. It is not possible to arrive earlier than the time of your reservation (also not for drinks).

All guests must be present when the reservation time starts.

We cannot guarantee an extension of the reservation in case of delays you might experience.

Delays of more than 20 minutes will result in an automatic cancellation and your table will be given to someone on our waiting list.

Cancellations

Pursuant to the "Consumer Agreements Act section 18 (2), no. 12", the purchase of tickets is not covered by the right of cancellation and therefore tickets cannot be refunded unless the event is canceled by the organizer.

If an event is canceled by The Caribbean Housewife, refunds are automatically returned to the payment method used for the booking and the customer is informed directly through their registered e-mail address.

It is not possible to change dates or times, without consent of The Caribbean Housewife.

It is not possible to refund or make changes on purchased bookings.

Refunds can not be made in case of illness or fear of infections – unless an agreement is made with The Caribbean Housewife.

No Show Conditions

A valid credit card is necessary for the full amount of the booking per person to guarantee your reservation.

There are no refunds possible for no shows.

Pre-payments and Refunds

All sales are final and we do not issue refunds. Should you need to reschedule your reservation, your prepayment can be converted into a gift card, if requested by e-mail at least 3 days / 72 hours before the reservation.

CATERING SERVICES & EVENT SPACE

All bookings must be confirmed in writing by the Client.

A full payment is required to secure the catering and/or space for the date of your event.

The catering assignment and/or event space is confirmed after receiving your payment, unless agreed otherwise.

In the unfortunate event of a booking having to be cancelled, confirmed in writing is needed by the Client.

Your deposit will be retained and/or the following charges will be incurred:

– Cancellation received with less than two months notice prior to the event – 50% of the total event cost.

– Cancellation received less than one month prior to the event – 100% of the total event cost.

The total event cost will be based on the number of confirmed guests attending at the agreed price per head + Danish VAT (moms). Should guest numbers be unconfirmed at the time of cancellation the total event cost will be based the originally quoted or estimated guests numbers.

Any additional costs incurred by The Caribbean Housewife in preparation of the event up until the time of cancellation or changes will be charged to the Client. This is to cover any losses caused to The Caribbean Housewife, such as administration costs (including invoicing), travel, supplies and will be presented fully in event of cancellation or changes.

The Caribbean Housewife provides catering services as outlined in the proposal and as agreed upon by the Client. The Caribbean Housewife is responsible for the preparation, delivery, and presentation of the food requested by the Client. The Client acknowledges that once the catering is served, the control over the portioning and distribution of catering to guests rests solely with the Client and their event coordinators or servers. The Caribbean Housewife is not responsible for monitoring or managing the consumption patterns of guests or the amount of food each guest consumes. The Client agrees to arrange appropriate crowd management to ensure all guests receive the catering as intended and to prevent any form of uneven food distribution at their designated food service areas.

The Client agrees to pay for any loss or damage to any equipment, catering boxes, supplies, cutlery or glassware supplied by The Caribbean Housewife for the event, including any issues caused by guests of the Client. All property from The Caribbean Housewife shall be returned in the original state and clean / disinfected. Non-returned or uncompensated property loss of The Caribbean Housewife is considered a theft and shall be reported to the lawful authorities.

The Client is responsible for adhering to the current governmental guidelines and regulations, including the number of guests allowed to assemble. During possible pandemic regulations, delivery can not be done in person and shall be delivered contact free and/or by a third-party, e.g. professional taxi service.

Client complaints should be done in writing as soon as possible, yet within 24 hours after the event.

SECTION 1 – WHAT DO WE DO WITH YOUR INFORMATION?

When you purchase something from our store, as part of the buying and selling process, we collect the personal information you give us such as your name, address and email address.

When you browse our store, we also automatically receive your computers internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

Email marketing (if applicable): With your permission, we may send you emails about our store, new products and other updates.

How do you get my consent?
